Sub : Circulation of revised guideline of distribution of Tractor under CMSGUY- Action thereof.

Sir,

I am to forward the list of 7 (seven) lowest quoted models of tractor in each of 3 categories, as approved by the Cabinet. The revised guidelines and operational guidelines duly approved by the Govt. of Assam is also enclosed along with all required formats.

The farmers will have an option to procure implements from 7 (seven) lowest quotations for tractors in each category or from other manufacturers who participated and qualified in the quotation process provided they are in the price range as mentioned in Annexure-B.

In any case, the optional purchase of implements should match with the main tractor unit without compromising the warranty or performance of the tractor. Furthermore, the optional implements should be purchased from the same dealer from whom the tractor will be purchased because subsidy is to be released to single point in a package from under the guidelines of the scheme.

The subsidy will be limited to the extent available to the lowest quoted price for the particular implement in each of the three categories from amongst 7 lowest qualified bidders for the tractors.

Please arrange to circulate the choice form to be submitted by all the selected groups of beneficiaries of tractor to make their choice as per approved shortlisted brand /model of tractor and matching implements. Please ensure that list of shortlisted tractor model, matching implements and their rates are displayed in your office premises to enable the farmers group to make an informed choice.

A timeline indicating implementation schedule of the scheme is enclosed for timely implementation of the scheme.
