In pursuance of Govt. letter No.AGA.326/2016/331 dated.22.02.2018, the Department of Agriculture, Govt. of Assam hereby invites fresh competitive rates of Tractor and Matching Implements from the manufacturers of tractors who have participated in the scheme in response to notice inviting competitive rates of tractor and matching implements vide No. Agri/Engg/4632/CMSGUY/2017-18/66 dated. 07.07.2017 with the following terms and conditions:

- 1. The manufacturer would offer most competitive rates for 1 (one) model in each of the following 3 (three) categories as per Format-A:
 - I. 35 or more than 35 PTO HP and up to 40 PTO HP.
 - II. More than 40 PTO HP and up to 45 PTO HP.
 - III. More than 45 PTO HP and 50 PTO HP.
- 2. The manufacturers and the quoted models must be approved by Govt. of India and registered on Farmer's Portal (http://farmer.gov.in).
- 3. The Manufactures shall quote most competitive rates along with manufacturer details for each of the 5 (five) Matching Implements (viz. Cage Wheel, Cultivator, Disc Harrow, Rotavator and 5 tonne hydraulic tipping type trailer) for each of the models of tractors as per the specifications mentioned in Annexure-A.
- 4. Most competitive rates offered by 7(seven) manufacturers in each category of models mentioned above would be selected and notified for procurement by the selected beneficiary groups as per their choice. In case, less than 13 (thirteen) quotations are received in a category, lesser than 7(seven) models may be selected.
- 5. The beneficiary farmers would be given option to procure or not procure all or any of the 5 (five) matching implements (mentioned in Sl. No.3 above).
- 6. Bank loan is not mandatory for beneficiary groups for procurement of tractor and implements.
- 7. The rates quoted for tractor would include cost of training about operations, service and maintenance of tractor to the beneficiary group, one-year warranty, delivery of the tractor at sight (FOR), registration of tractor and trailer with RTO and one-year insurance.
- 8. The beneficiary group may procure the tractor of selected model and make along with implements, if so opted, from any authorised dealer of the manufacturer in the state. The group may negotiate with the dealer to bring rates below the price quoted by manufacturer.
- 9. The tractor purchased by the beneficiary group shall not be transferable/leasable/saleable for a period of 5(five) years from the date of registration.
- 10. Guidelines approved by the Mega Mission Society-Chief Minister Samagra Gramya Unnayan Yojana (Govt. of Assam) shall be binding for procurement of tractors and matching implements.

11. The fresh rates should reach the office of the Chief Engineer, Agriculture on or before 05.03.2018.
